

Statement of Compliance with Restricted Materials Regulations 05/23/25

PLC Multipoint is committed to meeting its legal obligations and social responsibilities in terms of disclosure of the use of restricted materials.

REACH

Article 33 of the European Union's REACH (Registration, Evaluation, Authorization and Restriction of Chemicals, EC No. 1907/2006) chemicals regulation requires a supplier of manufactured and imported articles to communicate Substances of Very High Concern (SVHC) to the downstream recipient in the supply chain if the SVHC is present above a concentration limit of 0.1% weight as compared to the total weight of the article. SVHCs are listed in Annex XVII of the REACH directive that is published by the European Chemicals Agency. The latest update to the Annex XVII list was published on January 21, 2025.

We continue to be committed to taking the necessary steps for REACH compliance. As part of our efforts, we require our suppliers to provide information regarding REACH compliance of materials they supply to us. PLC Multipoint products do not knowingly contain restricted chemicals in excess of listed thresholds per the REACH Annex XVII Restricted Materials List.

RoHS

The EU Directive 2011/65/EU "Restriction on the Use of Certain Hazardous Substances" (RoHS2) and subsequent amendments up to and including 2015/863/EC requires all Member States (per Article 4(1) of the Directive) to ensure that materials and components of electrical and electronic equipment put on the market do not contain more than 0.1% by weight of the following specific substances: lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls (PBBs) or polybrominated diphenyl ethers (PBDEs), or the phthalates Bis(2-ethylhexyl) phthalate (DEHP), Butyl benzyl phthalate (BBP), Dibutyl phthalate (DBP), Diisobutyl phthalate (DIBP).

We continue to be committed to taking the necessary steps for RoHS compliance. As part of our efforts, we require our suppliers to provide information regarding RoHS compliance of materials they supply to us. PLC Multipoint products do not knowingly contain substances listed in the RoHS Directive.

PFAS

Perfluoroalkyl and Polyfluoroalkyl Substances (PFAS) refers to a very broad range of substances that are widely used, long lasting chemicals, components of which break down very slowly over time and may be linked to harmful health effects in humans and animals. The PFAS description covers thousands of different chemicals with very different properties and characteristics. Currently the U.S. EPA PFAs reporting deadline has been extended to October 2026.

PLC Multipoint products do not knowingly contain restricted PFAS chemicals in excess of listed thresholds per the REACH Annex XIV Candidate List as updated in Jan. 2023.

Prop 65

Proposition 65 became law in November 1986. Its official name is the [Safe Drinking Water and Toxic Enforcement Act of 1986](#). Proposition 65 requires businesses to provide warnings to California residents regarding significant exposures to chemicals that cause cancer, birth defects or other reproductive harm that may take place when products are acquired or used. Exposure may also occur in homes, workplaces, or other environments in California. Proposition 65 requires publication of a list of chemicals known to cause cancer, birth defects, or other reproductive harm. This list was first published in 1987 and must be updated annually. It now includes over 900 chemicals.

Conflict Minerals

Conflict Minerals refer to raw materials or minerals that come from a particular part of the world where conflict is occurring and affects the mining and trading of those materials. Conflict metals include tantalum, tin, gold, tungsten and their derivatives. Section 1502 of the Dodd-Frank Wall Street Reform and Consumer Protection Act provides guidance regarding the due diligence process for determining the use of conflict minerals.

We continue to be committed to taking the necessary steps to avoid the use of conflict minerals. As part of our efforts, we require our suppliers to provide information regarding conflict mineral content of materials they supply to us. PLC Multipoint products do not knowingly contain materials sourced from conflict-affected locations.
